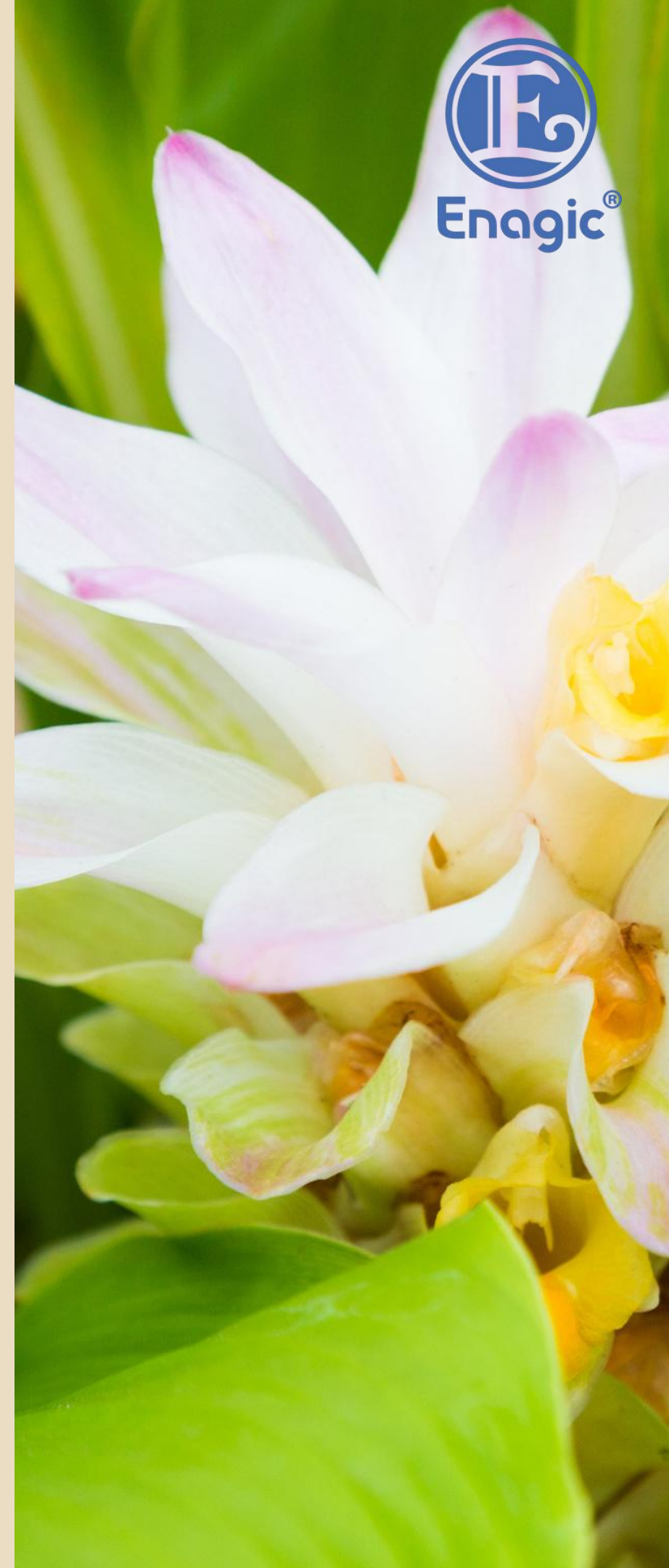

TURMERIC MANUFACTURING PROCESS



1. Turmeric is harvested by contracted farmers and delivered to the factory.



2. Super 501s are used for cleaning and sterilization. Peeling turmeric will help reduce soil bacteria.



3. Washing with strong acidic water through a low-pressure shower tunnel.



4. Rinse away dirt with high-pressure water.



5. Strong reduced water returns acidity to neutral, preserving flavor and quality.



6. Sliced turmeric passes through a conveyor and enters dryer.

TURMERIC MANUFACTURING PROCESS



7. Dried turmeric chips are transported by an air conveyor and powdered.



8. Coarsely powdered turmeric is put through a distiller to extract spring and autumn turmeric oil, used in the supplements and soap.



9. Autumn turmeric powder used to make Ukon tea is sterilized in a sterilizer.



10. Microbiological and physicochemical testing is performed in the Quality Control Department.



11. Turmeric powder passes inspection and is processed into Ukon tea.

Why maintaining an active Ukon ID matters

✓ Your **active Ukon ID** will keep your linked ID **SP Qualified**.

When you maintain SP Status, you receive:

100% + Special Point Bonus on all 8-point commissions.

100% commissions on incentives, filter sales, and Ukon commissions.

✗ If your Ukon account becomes **inactive**:

Your SP Status may be affected, which can result in loss of commissions from indirect sales.

↻ You would no longer receive commissions from sales of Ukon products from your Downline, Ukon sales will automatically **pass up** to distributors that have an active Ukon above you until 8-points have been distributed..

COMMISSION STATUS BREAKDOWN



Your SP status affects how much commission you earn on 8-point sales, filters, incentives, and Ukon.

F / No sales 0

- **\$0 commission** on 8-point sales, filters and incentives.
- Requirements: Last direct sale was over 1 year ago. No Valid Ukon Auto-ship program.

D1 / Direct Sales 1 Status

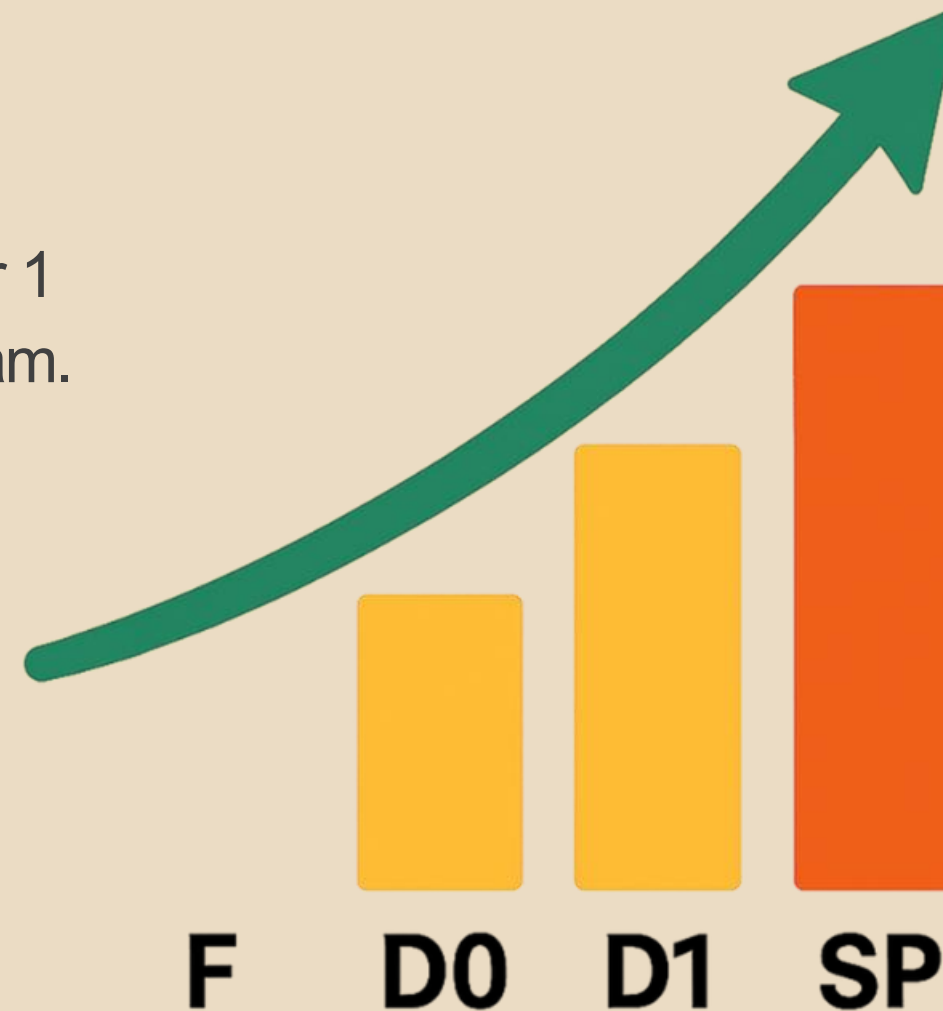
- 100% commission on 8-point sales without SP bonus. 100% on filters and incentives.
- Requirements: Last Direct Sale date was over 90 days ago, but still within 6 months from the day. No Valid Ukon Auto-ship program.

D-0 / Direct Sales 0

- 50% commission on 8-point sales without SP bonus. 50% on filters and incentives
- Requirements: Last Direct Sale Date was over 6 months ago. No Valid Ukon Auto-ship program.

SP / Special Point Status

- 100% commission on 8-point sales + SP Bonus
- 100% commission on filters, Ukon, and incentives
- Requirements: One direct sale within the last 90 days or **active enrollment in the Ukon auto-ship program (DD or Sigma)**

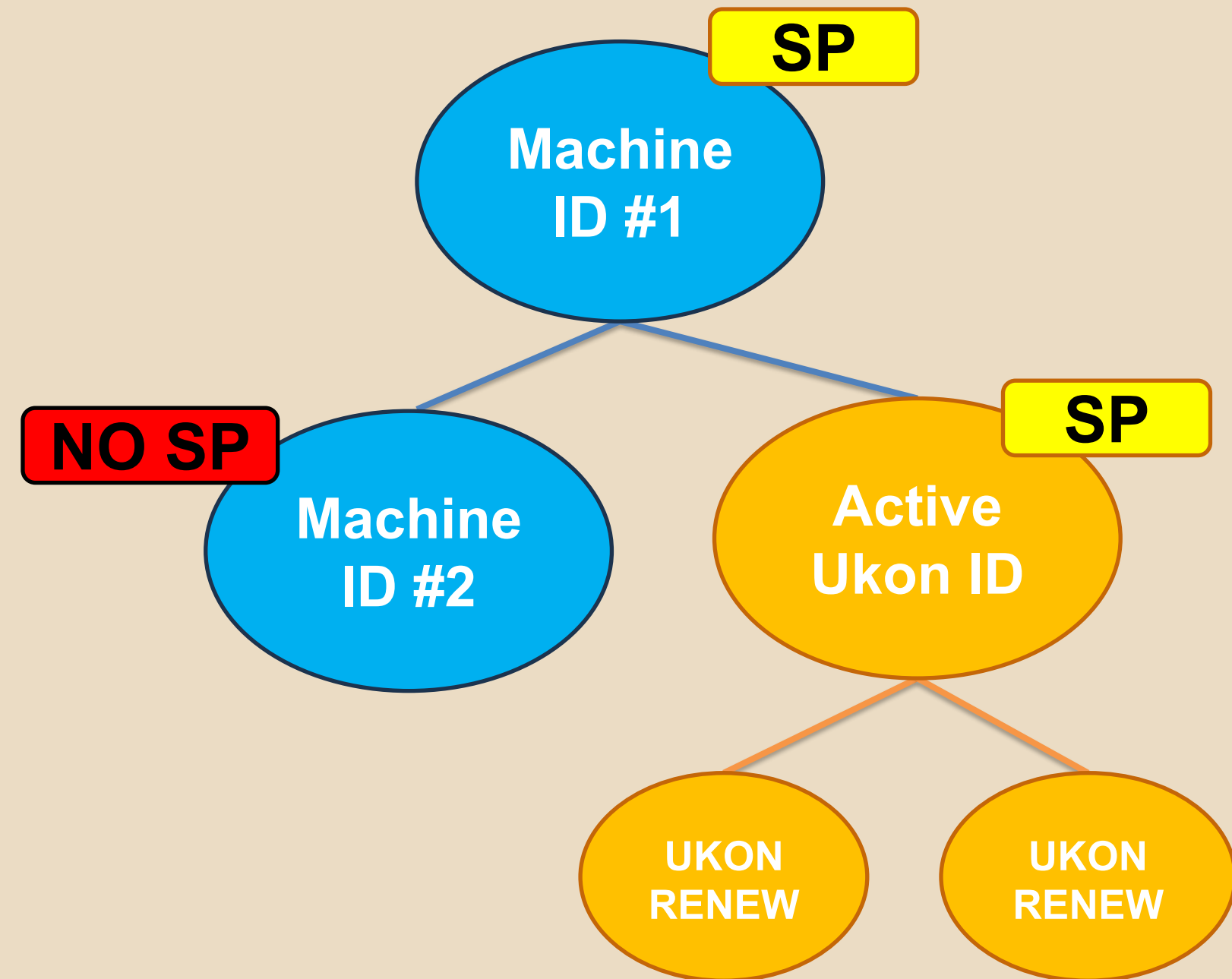
HOW UKON DD OR SIGMA HELPS MAINTAIN YOUR SP STATUS



✓ Each active Ukon ID# protects itself and one (1) linked account.

✓ To activate SP Protection, your account must make a direct Ukon purchase, names must match.

✓ If you have multiple accounts, an Ukon purchase is required for each account.



UKON COMMISSION PASS-UP



❌ No Active Ukon ID = No Ukon Commissions

Just like with Kangen Water, Enagic pays 8 points for every Ukon SIGMA or Ukon DD sale.

These commission points are paid from the bottom up, until all 8 points are distributed to whom has **Active Ukon** accounts.

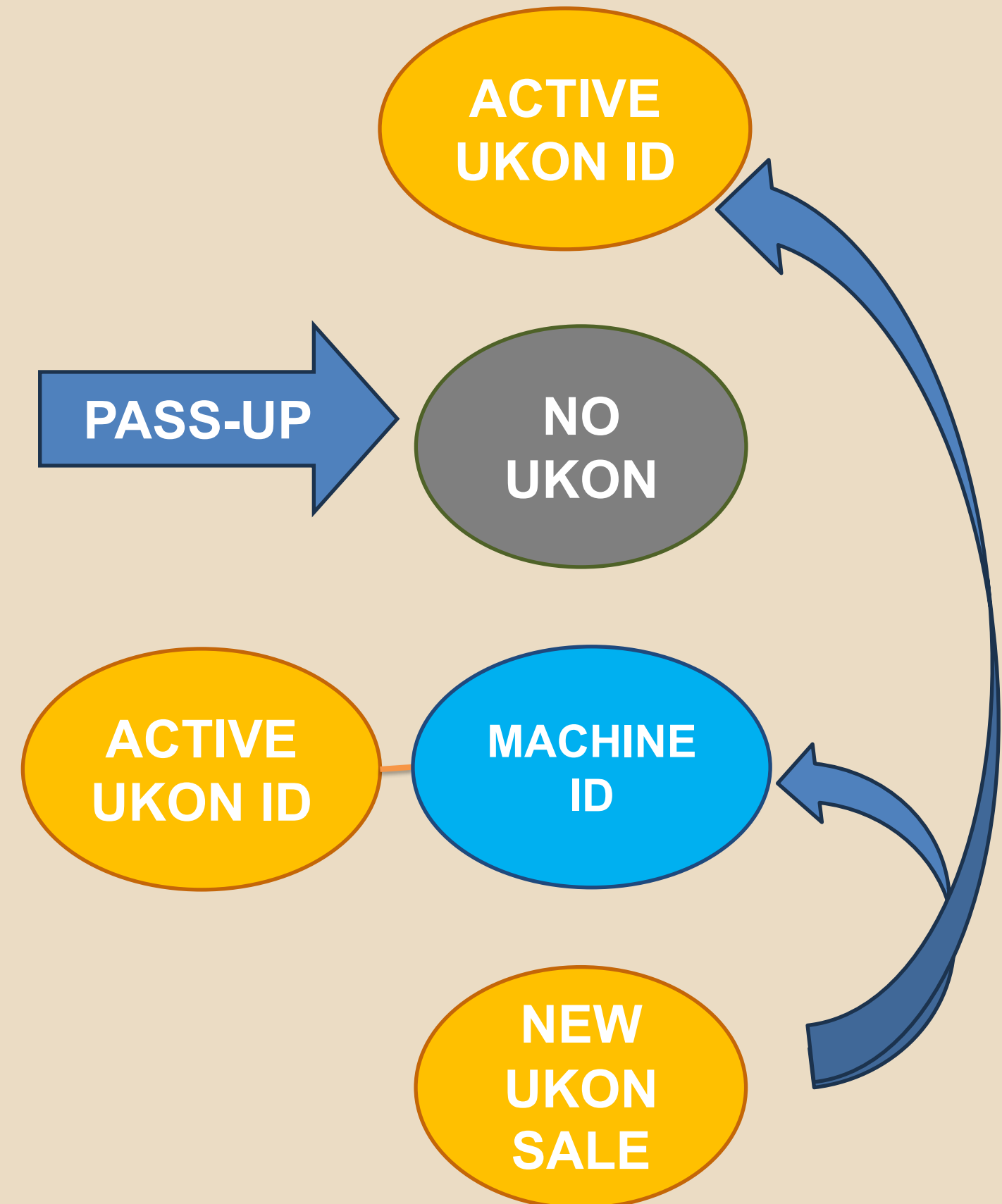
That means if you're not enrolled in Ukon DD or Sigma, your eligible Ukon commissions will pass-up to your next qualified upline.

Commission

\$40 per points for UKON DD,
\$115 per points for UKON SIGMA

If you **do not have an active UKON**, you will:

- ❌ Miss out on Ukon commissions
- ❌ Lose Ukon sales



UKON DD PROGRAM



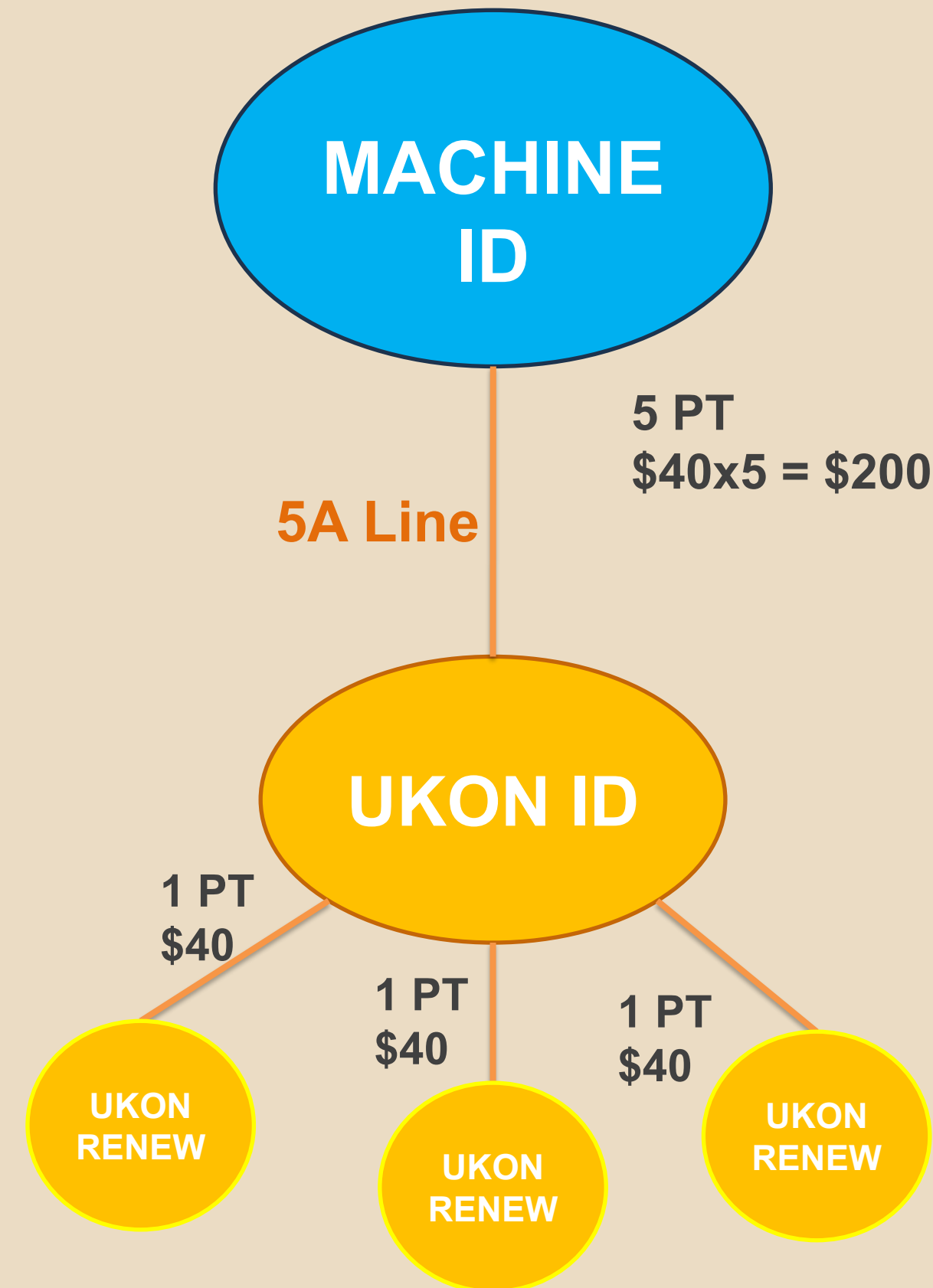
Group Sales Total and Faster Rank UP Promotion

- Each Ukon DD sales count as (1) 8-Point sale!
- Customers receive a new shipment every 4 months via auto-ship program.
- You earn recurring commission every 4 months per active DD customer.
- 3 sales per year from just one customer!
- Ukon DD helps boost group sales totals and accelerate rank advancement.

Commission Payout Details

Ukon DD Commission will be issued once \$160+ is accumulated.

You must have an active Ukon account to receive Ukon commissions.



UKON DD 1-YEAR COMMITMENT



Ukon DD is at least **1 year commitment program**

If cancelled before completing 1 full year, the Ukon DD account(s):

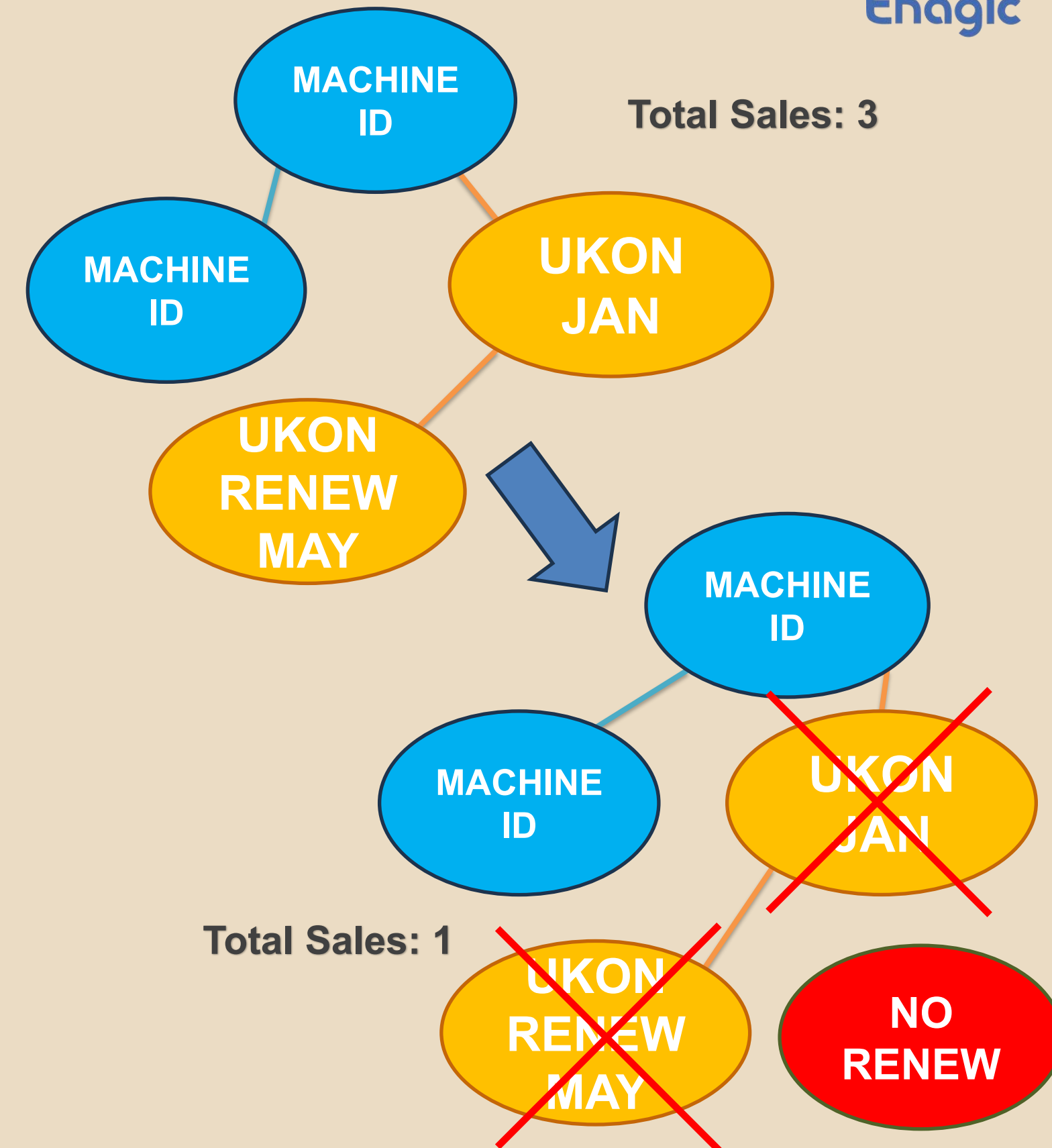
- ✗ Will be **removed** from your sales count
- ✗ Will **lose distribution rights** (cannot sell machines or Ukon products)

Example:

If a Distributor starts Ukon DD in January, renews in May, but does not renew in September, the 1-year commitment is not fulfilled. As a result, both the January sale and May renewal will be canceled and removed from the Distributor's total sales. The Ukon account will also lose commission eligibility and distribution rights.

Tip for Distributors:

*To protect your rank and income, stay active on Ukon DD for at least **1 full year**.*



TERMINATION AND REACTIVATION



✖ Termination

- All payments are due by the assigned due date.
- Failure to make a renewal or monthly payment within 10 days of the due date will result in account inactivation.
- All benefits that come with this program such as SP point & eligibility to sell Ukon and receive Ukon commissions will no longer apply to the account from the inactivation date.
- Missed commissions during an inactive period are not adjustable, even if the account is later reactivated.

🔄 How to Reactivate Your Account

To reactivate your Ukon DD or Sigma account, all the past due payments must be brought up to date and paid in full.

1. Complete and sign the Ukon Reactivation Form available at www.enagic.com under document download.
2. Email it to ukon@enagic.com
3. A \$50 reactivation fee will be charged per missed renewal.

IMPORTANT

- Distributors with D-0 or F status can regain SP status by enrolling in the Ukon DD or Sigma auto-ship program.
- 100% commission eligibility resumes from the date of the Ukon program enrollment.
- Ukon commission will be passed up if you do not have active Ukon account.
- Distributors are fully responsible for managing their Ukon DD or Sigma payments. If payment was not received within 10 days from the due date account will be inactivate.
- Any missed commissions during inactive periods are not adjustable, even if the account is later reactivated.

FREQUENTLY ASKED QUESTIONS

☐ Do I need to buy a Kangen Water® machine to build the business?

- No. You can build an Enagic® business solely by selling Ukon DD or SIGMA without purchasing or owning a Kangen Water® ionizer.

☐ How do Ukon DD/SIGMA sales count toward rank advancement?

- For rank advancement,
1 Ukon DD or SIGMA sale = (1) 8-Point sale (1:1 ratio)
- For incentives, campaigns, and awards:
1 Ukon DD = 1/3 sale (3:1 ratio) SIGMA = 1 sale (1:1 ratio)

☐ Can an Ukon DD-only distributor sell Kangen Water® machines?

- Yes. Ukon DD distributors are allowed to sell Kangen Water® machines and earn commissions.

☐ How much commission do I earn on Ukon DD or SIGMA sales?

- Ukon products follow the 8-point pass-up system. Distributors who are actively enrolled in the Ukon program receive commissions per point as follows:

- Ukon DD: \$40 per point
- Ukon Sigma: \$115 per point

- For example, if you are a 3A distributor and you purchase Ukon Sigma, you will receive:

\$115 × 3 points = \$345

☐ Can I upgrade/downgrade between DD and SIGMA?

- Yes, Once your Ukon account becomes permanent account (after 1 year) you are eligible to upgrade from DD to SIGMA or downgrade from SIGMA to DD.

☐ How do I cancel Ukon DD/SIGMA?

- Submit a Kangen Ukon Cancellation Form available at www.enagic.com under document download.
- Email it to: ukon@enagic.com.
- Must be sent at least 5 business days before your scheduled renewal payment date.

Your SP status ends the day you cancel unless you had a direct machine sale in the past 90 days — then your SP status will remain until it naturally expires.
